NOTES AND GATHERING, UNLOADING AND HANDLING CHARGES:

1. The rates herein include all charges for gathering, unloading and handling for all petroleum tendered for transportation under the tariff, except for Alexander Station and Skunk Hill Station where no gathering will be performed.
2. A [U] 19.52 cents per barrel unloading charge will be assessed for oil received at Alexander Station and delivered to Enbridge Pipeline.
3. Provided there are sufficient offsetting nominations, service to Alexander Station and Skunk Hill Station may be provided through displacement.
4. County designations are for convenience only and do not necessarily indicate the full extent of the named field.
