### JOINT TARIFF

Applying on the Transportation of  
Crude Petroleum

The rates published in this tariff are for the transportation of Crude Petroleum by pipeline subject to the regulations named in Belle Fourche Pipeline Company’s F.E.R.C. No. [W] ~~112.23.0~~ ~~112.17.0~~ or subsequent issues thereof and any further limitations specified in the local tariffs that comprise the joint movements specified herein. Rates are payable in U.S. currency.

\*As indicated in Bridger’s F.E.R.C. No. 32.8.0, all petroleum movements received at North House Creek Truck Stations, Savageton Truck Station, Hwy 59 Truck Station, and Fields Served by Gathering Segments in Campbell County, Wyoming must have (1) an API gravity of thirty-six (36) degrees or greater, and (2) less than 0.30% sulfur by weight.

#### JOINT ROUTING:

Bridger Pipeline LLC – Origin Stations, all in Campbell County, WY connecting to:  
Belle Fourche Pipeline Company – in Campbell County, WY for further delivery to Belle Fourche Guernsey HUB, Platte County, WY.

#### NOTES:

Where a gathering service is performed by Bridger Pipeline LLC at the Fields Served by Gathering Segments in Campbell County, WY, a gathering charge of [D] ~~45.39~~ cents per barrel will be made in addition to the transportation rates named herein.

Additional charges are applicable for movements beyond Belle Fourche Guernsey HUB to connecting carriers, as set forth in Belle Fourche’s F.E.R.C. No. [W] ~~129.7.0~~ ~~129.0.0~~ and subsequent reissues thereof.
